(Corrections) Notification of Partial Corrections to "Consolidated Financial Results for the Six Months Ended June 30, 2025 (Under Japanese GAAP)"

Toyo Tanso Co., Ltd. (the "Company") hereby announces that certain corrections have been made to the "Consolidated Financial Results for the Six Months Ended June 30, 2025 (Under Japanese GAAP)" released on August 21, 2025. The details are as follows, with the corrected sections are underlined.

Particulars

1. Reason for correction

Due to a misclassification identified in revenue recognition for the first three- and six-month periods of the fiscal year ending December 31, 2025, at SHANGHAI TOYO TANSO CO., LTD., one of the Company's consolidated subsidiaries, corrections have been made to the reported figures for net sales, orders, and outstanding orders related to "Special graphite products" and "Compound materials and other products".

Note that there are no changes to the company-wide figures for net sales, orders, and outstanding orders.

(2) Overview

(Before correction)

Special graphite products

In electronics applications, sales decreased by <u>41.5</u>% year on year mainly due to a significant sales decrease of products for compound semiconductor manufacturing applications for SiC (silicon carbide) semiconductors and products for single-crystal silicon.

In general industries applications, sales decreased by <u>10.7</u>% year on year mainly due to <u>a sales decrease of EDM</u> <u>electrode</u>, and weak performance of products for metallurgical applications including those for continuous casting and industrial furnaces.

Due to these factors, sales of special graphite products overall were down 23.6% over the previous year.

Compound materials and other products

Sales of SiC (silicon carbide)-coated graphite products <u>increased</u> year on year, mainly due to <u>a sales increase of Si</u> (silicon) semiconductors, despite a significant decrease in sales of SiC (silicon carbide) semiconductors. Sales of C/C composite products decreased year on year due to sales decrease of products for industrial furnace applications. Sales of graphite sheet products decreased year on year due to a decline for special applications, despite solid sales of products for automobile applications, semiconductor applications, and metallurgical applications.

Due to these factors, sales of the three major products <u>were equivalent</u> to the same period of the previous year, and sales of compound materials and other products <u>increased 3.3</u>% over the previous year.

(After correction)

Special graphite products

In electronics applications, sales decreased by 30.7% year on year mainly due to a significant sales decrease of products for compound semiconductor manufacturing applications for SiC (silicon carbide) semiconductors and products for single-crystal silicon.

In general industries applications, sales declined by <u>5.4</u>% year on year, mainly due to <u>a decrease in sales of EDM</u> <u>electrodes</u>, <u>despite solid performance in products for metallurgical applications including those for continuous casting</u> and industrial furnaces.

Due to these factors, sales of special graphite products overall were down 16.3% over the previous year.

Compound materials and other products

Sales of SiC (silicon carbide)-coated graphite products <u>declined</u> year on year, mainly due to <u>a significant decrease in sales of SiC (silicon carbide) semiconductor applications</u>, <u>despite an increase in sales of Si (silicon) semiconductor applications</u>. Sales of C/C composite products decreased year on year due to sales decrease of products for industrial furnace applications. Sales of graphite sheet products decreased year on year due to a decline for special applications, despite solid sales of products for automobile applications, semiconductor applications, and metallurgical applications.

Due to these factors, sales of the three major products <u>declined 12.4%</u> over the same period of the previous year, and sales of compound materials and other products <u>decreased 7.2%</u> over the previous year.
