Notification of liquidation of non-consolidated subsidiary

At a Board of Directors meeting held on December 20, 2017, the Company decided to liquidate its non-consolidated subsidiary TOYO TANSO GRAPHITE AND CARBON PRODUCTS INDUSTRY AND COMMERCIAL A.S. as part of the reforms to business structures announced on February 12, 2016. The details are provided below.

Particulars

1. Reasons for liquidation

The Company established TOYO TANSO GRAPHITE AND CARBON PRODUCTS INDUSTRY AND COMMERCIAL A.S. in Turkey as its processing and manufacturing base in Europe and pursued marketing activities with the aim of establishing a business foundation. However, in light of market trends, the business environment, and political conditions, as well as conservative estimates of the future profitability of this non-consolidated subsidiary, the Company determined that its contribution to revenue would be low and has accordingly decided to liquidate the company.
