 efficiency of operations.

<Technical Development Division>


- Materials Development Department will be established, the objectives of which are to achieve sustained improvement of technological skills, as well as speed up creation of new products and newly-developed products, and enhance manufacturing operations.
- Technology Research Department will be established in order to strengthen expansion into new business domains and new technologies as well as to promote development of high value-added products.
- In order to promote an intellectual property strategy based on medium- and long-term development strategy, and to strengthen Group-wide management of intellectual property, the intellectual property function will be separated and transferred from Legal Department, General Administration Division, and Intellectual Property Section will be established.
