Notice of Structural Reform and Personnel Changes

The Company hereby announces the following structural reform and personnel changes, effective January 16, 2019.

Particulars

- 1. Structural reform (as of January 16, 2019)
 - Regional management system under Directors and Executive Officers will be abolished following the establishment of Global Affiliated Companies Administration Department (effective July 1, 2018) which has put in place a structure for supervision of overseas subsidiaries under the Head Office control.
 - In order to promote reform of the carbon brush business and construct an efficient production structure through stronger collaboration with Totan Kako Co., Ltd. (a fully-owned subsidiary of the Company), Carbon Brush Department will be established within Production Division.
 - In order to promote launch of new businesses and facilitate prompt establishment of efficient production structures for existing businesses, Green Innovation Development Department will be abolished, and the functions under its management will be organized as sections, to be transferred to Technology Research Department in Global R&D Division and Advanced Material Department in Production Division.


